<b>Kim Eberhard</b>
Kim Eberhard is a professional archivist with over 15 years' experience in non-government archives. She has worked extensively with independent schools, religious orders and community organisations such as charities, historical societies and professional associations. Kim was President of the Australian Society of Archivists (ASA) from 2006 to 2008, and served on Council for a total of five years. Kim has been a member of the International Council on Archives since 2004 and Chair of the Section on Archives of Churches and Religious Denominations from 2008-2012. Kim co-authored the ASA's Records retention schedule for non-government schools. In 2009 she received an ASA Mander Jones award for her work as part of the team which wrote and edited Keeping Archives, 3rd edition. Kim was a member of the international working group responsible for the development of the Universal Declaration on Archives.
<b>Colleen McEwen</b>
Colleen McEwen completed formal archival qualifications from the University of New South Wales in 1977 and has been engaged in professional archivist since that date. She has worked as an archivist at the State Archives of South Australia (1977-1982), the Noel Butlin Archives Centre at the Australian National University (1982-1992), the Department of Defence (1992-1997) and at the National Archives of Australia (1997-2007). In 2007 she set up a records and information management consultancy business in Canberra. Colleen has contributed to professional activities including serving as a Councillor between 2001 and 2003 and was the ASA's representative on the Steering Committee of the ICA Section of Professional Associations between 2004 and 2012, holding the position of joint secretary from 2008. Colleen was the Project Manager of the international working group responsible for the development of the Universal Declaration on Archives.
